

## George W. Mitchell Of Arlington Street Heart Victim

George W. Mitchell. 77, one of the founders of the Woodfords Club and its only secretary, and long prominent in the life insurance circles in this City, died suddenly this morning at his home, 43 Arlington Street. He was stricken shortly after rising and died almost instantly. Death was due to angina pectoris, with which

he had been afflicted for some years. Mr. Mitchell was born in Portland Feb. 6, 1858, the son of Grenville P. and Marguerite Mitchell, will known residents of this city. He received his education in the city schools, and following his graduation from Portland High School was engaged in the dry goods business, which his grandfather established and conducted on Middle Street. He afterwards traveled for several dry goods firms, selling in Maine, New Hampshire and Vermont. Since 1898 he had been engaged in the insurance business here with the Northwestern Mutual Life Insurance Company. He was about his business Saturday and in his usual health when he retired Sunday night.

He leaves besides his wife, Mrs. Ada Mitchell, one son, Charles B. Mitchell, and a sister, Miss Mary E.


Mr. Mitchell's first wife the former Mary Osborne, died in
