

Karl M. Pattee. 88, of Cambridge, a retired colonel in the Army Corps of Engineers, who served in both world wars, died Saturday in Mt. Auburn Hospital In Cambridge after suffering a ruptured aneurism. Col. Pattee had been ill with a lingering coronary heart disease. 5-18-85

After World War II he was executive officer for the Corps of Engineers in Boston until 1948, when he took on civilian status Brooklyn, N.Y., and worked for an architect in Portland, Maine, and for an architect-engineering firm in Boston from 1925 to 1928.

His wife, the former Marjorie Haworth of Cambridge, said during a telephone conversation yesterday that he was self-employed from 1928 until 1933 during the Depression. "It was a hard time and we had to use up our savings ... "Then in 1933, she continued. he was called to active duty as a reserve officer and went on duty with the old Civilian Conservation Corps in charge of construction and maintenance of CCC camps in New England." He had been with the Army Corps of Engineers during World War I.

Col. Pattee was a member and a deacon of the First Church Congregational in Cambridge, a member for life of the Limington (Maine) Masonic Lodge and a 32d degree Mason; and a past president of the Boston Philatelic Societv.
