Edward Stanton Reed

BOOTHBAY -- Edward Stanton Reed, United States Army Veteran and former Boothbay town selectman, died Thursday, Dec. 21, 2006 at the Maine Veteran's Home in Augusta after a long battle with Alzheimer's disease. He was 83.

Born on July 21, 1923, to Carrie and Charles Reed, Edward went on to define his life through serving his country and his community. He enlisted in the U.S. Army during World War II, and served as a member of the 2nd Infantry Regiment with the European African Middle Eastern Campaign. He then went on to serve as a Boothbay town selectman and school board member, as a Boothbay fireman and with the East Boothbay Water District.

On Oct. 18, 1941, Edward married Virginia Bartik. The two made their home in Boothbay and had their first child, Arthur, two years before Edward enlisted, during his employment at Samples shipyard. In 1947, twins Alan and Arnold joined Arthur.

In the years following Edward's tour of duty, he worked as a carpenter and as a caretaker on Capitol Island. He became well known throughout the community through willingness to serve and through his involvement with the Bay View Lodge. Edward was a 32-degree Mason and a Shriner, taking great pride in his membership and the brotherhood.

On June 13, 1988, Edward lost Virginia to cancer, after 47 years of marriage. In October of 1989, he married Charlotte L. Colcord. The two were married for 13 years before he lost her to cancer.







Ancient Land Mark Lodge, AF & AM. secretary of the Portland Widow's Wood Society, a director of Provident Loan Co., a trustee of Greenough Church Edifice Assn., Casco Homestead Saings and Loan Assn., the Three-Quarter Century Club of Maine, and Immanuel Baptist Church, where he

served variously as clerk, trustee and deacon. His wife, the former Milli-

cent Howatt Leard, died in 1949. Among survivors are a sister, Mrs. Percival Doxon, Waterbury. Conn., and a nephew, Harold Phipps, Ports-mouth, N.H.



He attended local schools and graduated from Portland High School in 1921. He received a degree in civil engineering at the University of Maine in 1925.

Mr. Reed worked briefly for the Great Northern Paper Co., Millinocket, and then was associated with a consulting firm in Boston. From 1933 to 1940, he worked with consultants and contractors on design and construction of highways, bridges and water supplies.

AS DESIGN engineer and resident engineer for the Portland Water District, he supervised construction of the 42-inch water supply main from Sebago Lake to Portland during the late 1930s.

In 1740, he joined the office of the constructing quartermaster at the Boston Army Base, assisting in the construction of harbor defenses.

In-1943, Mr. Reed joined the Civil Aeronautics Administration and served with it through its replacement by the Federal Aviation Agency until his retirement in 1966. Briefly, in 1953-54 he left the CAA to become highway engineer for the Maine Turnpike extension from Portland to Augusta.

As an official of the CAA and the FAA, he served as district airport engineer for the New England states from 1946 until 1965 when, with reorganization, he was made chief of the airport branch of the Boston area, consisting of the New England states and most of New York state.

At a retirement party in 1966, he was presented a bowl bearing an inscription for his "outstanding contribution to the development of aviation in Rhode Island" over the signature of Gov. John A. Chafee.

A REGISTERED professional, engineer in Maine, Massachusetts and New York, he was a member of the Boston Society of Civil Engineers. He was a member of Corner Stone Lodge, AF & AM and a member of Woodfords Congregational Church

He is survived by his wife, the former Carrie Esther Erskine; daughter, Mrs. Frank C. Rodway, Portland; granddaughter, and brother, Glen Reed. Portland.
